## Regional Transportation Improvement Program Recommendations (RTIPR) for NMDOT District 1 2016

**Key:** New Projects

### What is the RTIPR?

The Southwest Regional Planning Organization is the federally approved method for the State of New Mexico to determine southwest (Catron, Grant, Luna, Hidalgo Counties) regional transportation needs in consultation with local elected officials through a continuing, cooperative and comprehensive (3C) planning process.

The following lists of transportation projects, the Regional Transportation Improvement Program Recommendations (RTIPR), are the result of a continuous, multi-year, prioritization process for the review, rating and ranking of proposed transportation projects for recommended inclusion in the Statewide Transportation Improvement Program (STIP) with local government involvement in Surface Transportation Program, Transportation Alternatives Program, Off-System Bridge Program and the Highway Safety Improvement Program (HSIP). Local-led projects under these funding categories are required to be on this list to be considered for funding.

All highway improvement projects constructed with federal funds must be included in the Statewide Transportation Improvement Program (STIP), a list of funded projects updated quarterly and available on the NM Department of Transportation website or by contacting the SWRTPO planner, (575)388-1509 or [grajalvac1@swanmcog.org](mailto:grajalvac1@swanmcog.org).

The Roadway category funds construction, improvement, and other transportation-related projects on roads functionally classified as local or Minor Collectors, under certain conditions. Principal Arterial, Major Arterial, Major Collector and on roads functionally classified as Interstate.

## Bridge Project Recommendations:



NOTE: Bridge projects are listed here for reference purposes only. They are not presented as RPO prioritized projects. The projects are evaluated on their own merits.

Annually, the Federal Highway Administration (FHWA) in partnership with the states calculates sufficiency ratings for every bridge in the nation. (This rating is computer-calculated based on data provided by state and local agency bridge inspectors.) The sufficiency rating formula is based on four factors: 1. structural adequacy and safety; 2. serviceability; 3. functional obsolescence and 4. essentiality for public use. Based on a sufficiency scale of 0 - 100, bridges with a rating of 80 or less are eligible for rehabilitation funding. Bridges with a rating of less than 50 are eligible for replacement funding. All bridges on public roads are eligible for these funds.
